

## Stallion Service Contract For Transported Semen

1. This contract made between Wandering Star Ranch (herein referred to as breeder), and (purchaser) \_\_\_\_\_ for the mare \_\_\_\_\_ to the stallion **Federal Goods** for the 2011 breeding season is an amendment to the stallion service contract. The purchaser may not substitute another mare without the consent of breeder. Embryo Transfers are prohibited without the written consent of breeder.
2. Purchaser agrees to pay the following fees:
  - The non-refundable booking fee stated in the stallion service contract.
  - A \$125 collection fee for each shipment of fresh chilled semen.
  - Freight charges for shipment of fresh chilled semen.
  - The balance of the service fee and unpaid expenses as described in the stallion service contract.**All fees and costs must be paid before semen will be shipped.**
3. Reservation for shipped semen:
  - Fresh chilled semen will be collected and shipped on regular breeding days. Regular breeding days for transported semen include Monday – Friday. Saturday & Sunday collections are on a 'as needed' basis and overnight delivery is not always available for Saturday & Sunday collections.
  - All semen orders must be made by 11:00 a.m. Pacific Time the day before the requested collection date. Late orders are not guaranteed.
  - **Purchaser agrees to notify breeder when the mare shows first signs of heat.**
4. Conditions:
  - Semen shall be provided only to healthy mares in sound breeding condition as determined by a veterinarian.
  - In the event the mare is barren, open, not a maiden, breeder may require the submission of a recent negative intrauterine culture and biopsy.
  - Purchaser agrees to have mare examined for pregnancy by ultrasound and submit such results along with insemination and conception reports to breeder within 14 days after ovulation of that cycle.
  - Purchaser agrees to have mare examined for pregnancy by veterinarian at 28 days post ovulation and again at 60 days.
  - Purchaser agrees that chilled semen requires special handling and that attempts to breed any mare outside controlled conditions of an equine reproductive center can greatly reduce, and in some cases prevent, chances of conception.
  - **Purchaser agrees to return all insemination certificates to breeder within 30 days of insemination.** Failure to comply could inhibit registration of resulting foal.
  - All terms within the stallion service contract concerning the live foal guarantee will be honored.
5. Non- Assignment:
  - This contract cannot be assigned or transferred by purchaser.
6. Liability:
  - Breeder is not responsible for lost, delayed, or damaged semen and makes no representatives or warranties of any kind with respect to semen except that it is the stallion's and is viable semen at time of shipment.
